

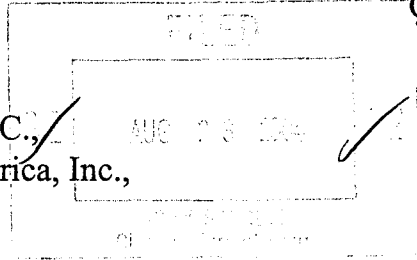

ORDER

This matter having come on for hearing on August 9, 2004 on *Plaintiff's Motion for an Order and Judgment for Plaintiff Awarding Damages Consistent with Jury Verdict, Stipulations of the Parties and Applicable Law, as well as Awarding Attorneys' Fees and Litigation Costs Pursuant to Sec. 218.0171(7), Wis. Stats. and Interest and Double Costs Pursuant to Sec. 807.01, Wis. Stats.*; that the plaintiff appeared by his attorneys, Jastroch & LaBarge, S.C., by Attorneys William S. Pocan and Susan M. Grzeskowiak, and the defendant appeared by its attorneys, Stafford Rosenbaum LLP, by Attorneys Bruce D. Huibregtse and Laura Skilton Verhoff; that based on the motion materials, oral arguments of counsel, the jury verdict, stipulation of the parties, and the entire file herein,

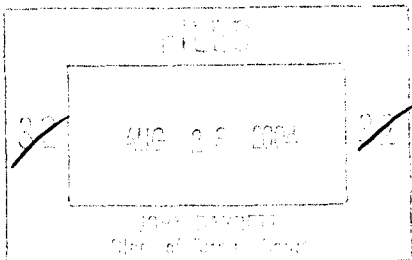
IT IS HEREBY ORDERED that for the reasons set forth on the record by the Court, the plaintiff is entitled to judgment in his favor, against the defendant, Audi of America, Inc.,

a/k/a Volkswagen of America, Inc., for the following, pursuant to sec. 218.0171(7), Wis. Stats. and sec. 807.01, Wis. Stats.:

1. \$93,519.62 for twice the amount of the plaintiff's pecuniary loss;
2. \$1,345.05 for pre-judgment interest at 5% (from 2/24/03 to 6/9/03);
3. \$13,099.50 for pre-judgment interest at 12% (from 6/10/03 to 8/9/04);
4. \$6,437.88 for statutory costs; and
5. \$70,000.00 for attorneys' fees;

that the Clerk of Circuit Court for Milwaukee County shall enter judgment accordingly in favor of the plaintiff and against the defendant, Audi of America, Inc., a/k/a Volkswagen of America, Inc., for the total sum of \$184,402.05 (the total of the above) forthwith; that upon full payment of this judgment, the plaintiff shall return the 2002 Audi TT Coupe that is the subject of this matter to the defendant, Audi of America, Inc., a/k/a Volkswagen of America, Inc., at International Autos, Milwaukee, Wisconsin, and provide the defendant with the certificate of title and all endorsements necessary to transfer title.
